OWN REQUEST WERE DR. O U D O N G SOUVANNAVONG, PRESIDENT OF

PROPOSAL FOR AID TO REFUGEES FOR UN CONSIDERATION. A UN REPRESENTATIVE IN THE FIELD OF REFUGEE MATTERS HAS BEEN SENT TO VIENTIANE
HAVING ARRIVED HERE ON 23 SEPTEMBER. DE. OUDONG SAID THE LAO RED
CROSS WANTED TO BE SURE THAT THE VIENTIANE SIDE WAS PREPARED AND
HOULD NOT PERMIT THE LAO PATRIOTIC FRONT (LPF) SIDE TO TAKE THE

- A. REFUGEES NOW RESIDING IN ONE ZONE WHO WANT TO RETURN TO THEIR LANDS IN THE OTHER ZONE.

REFUGEES SELF-SUFFICIENT AFTER THE FIRST HARVEST. THE VILLAGE OF KHOK VAN (TH 1607) LOCATED WITHIN THE 15 KILOMETER (KM) DEFENSIVE PERIMETER OF LUANG PRABANG WAS CITED AS AN AID RECIPIENT. THE LPF IT WAS NOTED HAD OCCUPIED THIS VILLAGE FOR SOME TIME BUT ARE NOW MOVING OUT.
