	5.	They wanted to know where was shot down. The roply was that he was shot down over Laos. They answered by saying that then perhaps it would be better if inquiries were made at the Laotian Embassy because Laos is a neutral country and North Vietnam has no influence there at all. As soon as it appeared that my friend would not or could not answer them they would hedge and open the discussion anew. They wanted to know who said was shot down over Laos. The reply was that a US Marine Corps casualty officer had given the information, but that he was not there, so really no one knew exactly where was shot down. Then they asked that if the US Government knew so much why wasn't it asked instead of my friend coming across the globe personally to inquire about The response was that obviously the US Government was not holding him prisoner and if he did in fact survive then he would be a prisoner in North Vietnam or Laos. Every time Laos was mentioned they became quite disturbed. They then asked if it were not possible that the US Government had made a mistake and that might not have known where the border was located. It was replied that it was very	
		reiterated the question that wasn't it possible the US Government could have been wrong. It was agreed that it was possible, but doubtful.	
	6.	At this point all were at loggerheads and so a list of US MIA's was presented to them for their verification. The list had been obtained from familius of MIA's in the US.
