PLAINTIFFS' MOTION FOR LEAVE TO FILE ONE-DAY LATE


Come now the plaintiffs, Roger Hall and Studies Solutions Results, Inc. ("Hall"), and move this Court for an extension of time, to and including October 29, 2010, within which to file their response to defendant's supplemental filing in response to this Court's order of November 9, 2009. As grounds for the motion, plaintiffs state to the Court as follows:

1. It appears from this Court's September 1, 2010 nunc pro tunc minute order granting defendant's motion for an extension of time to file Exhibit C to the Cole Declaration (Dkt. #151), that plaintiffs' response to defendant's supplemental filing is currently due on or before September 30, 2010.
2. Hall's counsel has this date completed a major brief in McGehee v. Federal Bureau of Investigation, et al., C. A. No. 01-1872, and only now can turn his attentions to this case. Defendant's filing is voluminous, probably consisting of close to 2,000 pages.

Hall has just returned from a trip out of town. He has begun reviewing defendant's voluminous filing.

3. Counsel for another plaintiff, Accuracy in Media, has also just returned from a trip out of town. Since defendant only served the paper copy of Cole Declaration Exhibit C, which appears to contain well over 1,500 pages of documents, he has not been able to begin reviewing these records yet. He will be able to do so shortly, when Hall's counsel's part-time office assistant completes scanning them. He joins in this motion.

4. Defendant does not oppose this extension..
