UNOPPOSED MOTION FOR EXTENSION OF TIME

On or before October 20, 2014, plaintiffs will respond to the CIA's motion for summary judgment and submit cross motions, if any;


On or before November 24, 2014, CIA will file its opposition/reply;

1. Plaintiffs' *Vaughn* index selections are currently due June 23, 2014.
2. The back supports on Plaintiff Roger Hall's wheelchair broke last week while he was attending an event involving POWs. As a result his spine was injured and he has been in severe pain since then and unable to work. His wheelchair was repaired on June 20th. Then the wheelchair lost its power. He has had some physical therapy which has abated his pain only to a minor degree. He will be going to another physical therapist on Monday, June 23rd
