JOINT STATUS REPORT

COME NOW all parties, by counsel, and move the Court as follows. On November 20, 2014, the parties filed a joint motion for stay (ECF No. 219) in order to attempt to resolve the issue of interim fees without the need for briefing. In that motion, the parties proposed to file a joint status report on or before January 16, 2015.

Based on the parties' discussions with respect to fees, it appears that a modest extension of the stay may prove fruitful with respect to advancing the fee discussion. Therefore, the parties jointly move the Court for an order that:

(1) The stay in this case shall be extended through and including January 26, 2015, pending settlement negotiations over payment of attorney fees and costs;

(2) On or before January 26, 2015, the parties shall file a Joint Status Report advising the Court of the status of the attorney fee negotiations, and if such negotiations have not been successfully concluded by that date, a proposed schedule for the filing of a motion for attorney fees and defendants' *Vaughn* index and dispositive motion.

The parties respectfully request a minute order.
