JOINT REQUEST FOR SCHEDULING ORDER

COME NOW all parties, by counsel, and move the Court as follows. On November 20, 2014, the parties filed a joint motion for stay (ECF No. 219) in order to attempt to resolve the issue of interim fees without the need for briefing. In that motion, the parties proposed to file a joint status report on or before January 16, 2015. A subsequent motion extended this date to January 26, 2015.


Based on the parties' discussions with respect to fees, it appears that the issue will need to be briefed. Accordingly, the parties request a scheduling order as follows:

- (1) Plaintiffs will file their respective petitions for interim fees on or before February 9, 2015;
- (2) Defendant will file its opposition to plaintiff's fee petition on or before February 23, 2015; and
- (3) Plaintiffs will file their replies with respect to fees, if any, on or before March 6, 2015.
- (4) The parties will shortly submit a joint report regarding a schedule for submission of defendants' Vaughn index and renewed motion for summary judgment.

(5) A proposed scheduling order on the motion for interim fees is submitted herewith.
