RHall8715: Remember, You previously told me that Red McDaniel was one person inside the POW camps that had contact with a CIA paid guard.

Drmwalker: yes

RHall8715: Who told you that?

Drmwalker: why?

RHall8715: We can get that and other hidden POW information if I can verify it. RHall8715: identifying such programs requires them to look in undisclosed program

areas.

Drmwalker: it was told to me by another POW who "served" at the Hilton with him.....not sure he will talk with you ... someone got to him and he quit talking to me ....he was a "Scout"

RHall8715: Let me and the lawyer talk to him. This may be the one shot to get the info. Going to members of Congress hasn't resulted in getting such info released. Where that info is hidden we might find other very sensitive POW info.

Drmwalker: ok... His name is Jose Jesus Anzaldua... he was a Marine....he now lives in Greensboro and is the Transportation director for the Guilford county school system... or he was.

RHall8715: Will you talk to him first so he knows I will call. He may freak out if I just call him up not knowing who I am. He should know that his info will come under the protection of the court.

Drmwalker: I will try.

RHall8715: This is really important. Remember I told you when I brought this up to Red he went dead silent on me, and would not respond - not even deny. He dosen't know where i got the info.

Drmwalker: LOL...yes he does. RHall8715: yes he does what?

RHall8715: Know where I got the info?

Drmwalker: He know it was I that spoke those words.... and he also know WHERE I got it... for I beleive that it was he or someone close to him that broke off our involvement.

RHall8715: I believe that, he has compromised some of my efforts also. He goes right to congress and who knows where else.

RHall8715: He runs to Sen. Smith with everything.

Drmwalker: yes

Subject: POW/MIA

I was in contact with chip Beck over the Internet today. Following are some revealitions that may help with the CIA search, and possible questioning if we get discovery.

The Russian's, E. Germans were suspected of capturing POWs there. Please get me included in the viewing.

Beck Chip: They are considering the request, and were generally positive. They are helping me with a specific case in Angola in which an American, a friend of mine, was killed by a Cuban patrol. His parents want to find the body after 22 years and have it returned home. On a humanitarian basis, I got a lot of cooperation on this one, from several corners, including official.

Beck Chip: The Cubans were there for 11 years, counting back from 1975.

Beck Chip: Will include some experts - nonDPMO - on the viewing once I set it up. I'll be going back down in early February.

RHall8715: I remember their African involvement well, the brush fire wars.

Beck Chip: I've got to run, take care of some other business. Have to talk later.
