## PLAINTIFF'S CONSENT MOTION FOR A FURTHER EXTENSION OF TIME TO FILE MOTION FOR RECONSIDERATION

Come now plaintiffs Roger Hall and Studies Solutions Results, Inc. and move this Court for an extension of time, to and including May 21, 2008, within which to file their motion for reconsideration of Magistrate Facciola's March 10, 2008 ruling on defendant's motion to strike the Declaration of Roger Hall. In support of this motion, plaintiffs represent to the Court as follows:

- 1. Plaintiffs' motion for reconsideration is presently due on May 14, 2008.
- 2. Plaintiffs' counsel has done some work on the motion for reconsideration since

the last motion for extension of time was filed, but that work had to be suspended for the past two weeks because of a trip to the Midwest and work on a brief due in the Court of Appeals in <u>Davy v. CIA</u>, D.C.Cir. No. 07-5200 on May 5, 2008, but not actually filed until late on the evening of May 6, 2008. Plaintiffs' counsel expects to resume work on the motion for reconsideration in this case on May 8<sup>h</sup>, but because of the death of a

family friend last Sunday evening, his work will be interrupted by a trip to attend the funeral services on May 9<sup>th</sup>, which will consume most of his available time that day. Counsel normally works a good deal on weekends, and plans to do so this Saturday, but his wife recently advised him that Sunday is Mother's Day, so relatively little work will be done on Sunday, May 11<sup>th</sup>.

3. While plaintiffs' counsel currently has a response to appellee's motion for summary affirmance due in the Court of Appeals on May 12, 2008, in <u>Davis v. Dept. of</u> <u>Justice</u>, D.C. Cir. No. 08-5024, he is moving to extend his time in that case until after he completes his motion for reconsideration in this case. This will clear away the time between May 12 and May 21 to focus on this case alone (except for some peripheral matters which may crop up).

4. Counsel for the CIA consents to this motion.
