Dear Mr. Clarke:

I refer you to our letter dated May 11, 2015, regarding the release of certain Department of State material under the Freedom of Information Act (the "FOIA"), 5 U.S.C. §552.

The search of the records of the Central Foreign Policy Records is partially complete and has resulted in the retrieval of 14 documents responsive to your request. After reviewing these 14 documents we have determined that 7 may be released in full, 1 may be released in part, and that 6 documents either originated in, or require consultation with, other U.S. Government agencies. We have referred the latter six documents to the relevant agencies with a request to respond upon making a determination as to releasability. All released material is enclosed.

Where documents are released to you in part, all non-exempt material that is reasonably segregable from the exempt material has been released. Where we have made excisions, the applicable exemptions are marked on each document. An enclosure provides information on FOIA exemptions and other grounds for withholding material.

Tripoli Working Group Call Summary - Monday, 14 November 2011

- The announcement for the new TNC cabinet members has been pushed back to 21 November as potential ministers jockey for positions. Many issues are stacking up with the various ministries awaiting the announcement.
- The MFA is pressing on the issue of diplomatic titles. To date Washington has only approved titles for the Ambassador and DCM. Titles are needed for many of the remaining embassy staff (which are TDY) leaving the issue for L and H to sort out.
- Tripoli RSO
 - Mostly quiet but tense today on the streets. Some check point activity along the roads.
 - Some gunfire was heard last night and there was reportedly clashes between Gaddafy loyalists and some militia members. No further information on what was happening.
- The Military doctor working with USAID has been looking for war wounded for another evacuation flight for treatment in Europe. So far only 11 patients have been located in Tripoli.
 They are now checking other cities for more possible evacuees.
- Tripoli GSO
 - ➤ Power problems are beginning to resolve. The land lord's generator has been repaired, but the automatic transfer unit still won't function and it is left in manual mode only.
 - > 3 x more USG generators installed on the compound II for the villas and the Ambassador's quarters.
 - > Tripoli currently has 15 LAVs, but some are in need of maintenance and Tripoli would like a few more if they can get them.
 - Tripoli is working on getting the HHE from former embassy staff shipped out. Working with the bureau to get copies of orders needed to process the shipments with the Libyan government.
- OBO
 - Work on the access point and the field expedient wall around the hill property and compound VI is continuing.
- The Options paper for M is still in staffing to develop the concept of operations for Tripoli through the end of 2012.
- Tripoli IMO
 - IRM REACH Tech Scott Moore has almost finished installing the MIPC equipment at the CMR. The Opennet servers are up and running. Exchange email accounts are being migrated to Tripoli from the WASHDC domain. Opennet workstations have been setup and additional cat-5 cabling is being installed. One of the switches isn't functioning correctly.
 - > Tripoli is requesting that the personal and shared folders that had been stored on an ESOC

server be transferred back to Tripoli to \\ NEASA\ TRIPOLIFP01\ D drive as soon as possible.

- The Ambassador, DCM and Tripoli Management have requested that SMART be activated for Tripoli as soon as possible.
- Tripoli is also requesting an additional IMS to handle the added work load of the two operating sites (CMR & Compound) as well as the added work load from SMART. Tripoli IMO suggested RIMC System Operations Officer Pete Steitz would be a good fit if available.
- The Tripoli VSAT has gone down once or twice a day. Tripoli IMO has been able to reset it each time.
- > The replacement parts for the Benghazi VSAT should be arriving tonight. IRM REACH Tech Scott Moore is scheduled to go to Benghazi 17 November to work on it.
- CA re-iterated the desire to get some consular systems up and running in Tripoli at the earliest opportunity. They may have consular server equipment available for shipment around January 2012.

The Tripoli Working Group call schedule is now set for Mondays and Thursdays.

The next Tripoli Working Group call will be on: Thursday, 17 November 2011 at 11:30 EST.
