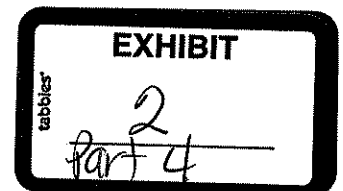

**Document Description :** Information is withheld from pages 1, 2, 15-32, 34, and 35 of this document on the basis of Exemption (b)(2). On page 1 of this document, an internal CIA identification number is withheld on the top of the page and a classification block at the bottom are withheld; on page 2, the component-addressees in the distribution block on page 2 were withheld; on pages 15-32, internal OGC document identification numbers were withheld; on pages 34 and 35, all of the information in columns 1-4 and 6-7 is internal agency administrative information. In addition, the name and identifying information of a third party, who was seeking assistance in recovering the remains of a relative, were withheld in the last paragraph of the last page of the document on the basis of FOIA exemption (b)(6) because disclosure of this information would constitute a clearly unwarranted violation of personal privacy. Finally, the author of the memorandum, whose name appears on pages 1 and 2, was a covert employee. Accordingly, his name in connection with CIA is classified, and is exempt as an intelligence method on the basis of FOIA exemption (b)(1).
