UNOPPOSED MOTION FOR FURTHER EXENTION OF TIME TO
FILE RESPONSE TO CIA'S SUPPLEMENTAL MEMORANDUM

Come now the plaintiffs, Roger Hall and Studies Solutions Results, Inc., (hereafter collectively referred to as "Hall"), and Accuracy in Media, and move this Court for a further extension of time, to and including April 1, 2011, to respond to the CIA's Supplemental Memorandum in Response to Court's November 12, 2009 Order. As grounds for this motion, plaintiffs state to the Court as follows:

1. Plaintiffs' response is currently due on March 25, 2011.
2. Plaintiff Hall's counsel was sick most of the time between March 8 and March 16, 2011. In addition, on March 8, 2011 the United States Supreme Court handed down its decision in Milner v. Dept. of the Navy,

562 U.S. ____ (2011) on FOIA exemption 2. This required counsel to work on the impact of this decision on at least seven of his pending cases, including most immediately, Morley v. Central Intelligence Agency, D.C. Cir. No. 10-5161, which was orally argued before the Court of Appeals on February 15, 2011, the day before counsel left on a trip to Singapore.

3. Because of these activities, counsel did not personally meet with plaintiff Roger Hall until March 20, 2011, for an initial conference to discuss the case. A further conference is scheduled this Sunday.

4. Plaintiff Accuracy in Media also needs additional time.

5. Defendant does not oppose this motion.
