**CONSENT MOTION TO ENLARGE TIME TO FILE OPPOSITION TO MOTIONS  
FOR INTERIM ATTORNEY’S FEES**

Defendant, the Central Intelligence Agency (CIA), respectfully moves the Court to enlarge its time to file an opposition to plaintiffs’ motions for interim attorney’s fees.

1. The current deadline for the CIA’s opposition is February 23, 2015, and the CIA seeks an additional 4 days, through and including February 27, 2015, to file that opposition.
  
2. The additional time is necessary because undersigned counsel presently has motions for summary judgment due in two other cases in this Circuit on February 23, the same date on which the CIA’s opposition is due in this matter. *See Elkins v. FAA*, No. 17-1791 (JEB); *Pinson v. DOJ*, No. 12-1872 (RC). With the Federal holiday and government closure due to inclement weather, it has proved exceptionally difficult to research this fact-intensive matter while also drafting those motions.

3. On February 19, 2015, undersigned counsel conferred with plaintiffs' counsel by email and telephone, and they expressed no opposition to the requested relief.

Accordingly, the CIA requests an additional 4 days, through and including February 27, 2015, to file its opposition to plaintiffs' motions for interim attorney's fees. In order to preserve the agreed-upon time for plaintiffs to reply, under the relief proposed, plaintiffs' replies deadline should be reset to March 12, 2015, *i.e.*, 4 business days after the present deadline of March 6, 2015. A proposed order is attached.
