This is in further response to your Freedom of Information Act (FOIA) request for access to records in the custody of the National Archives and Records Administration (NARA). Our office received your request for various records relating to possible Prisoners of War on June 26, 2020.

We assigned your request the case number listed above. Please use this number when communicating with us regarding your case so we can easily identify it.

As referenced in our correspondence dated November 3, 2020, we sent copies of the remaining 6 documents totaling 73 pages, and 10 documents previously released in redacted form, to appropriate agencies for further review. The Central Intelligence Agency (CIA) declassified 3 documents totaling 26 pages; released 9 documents totaling 31 pages with portions denied under section (b)(l) of the FOIA, 5 U.S.C. 552. Exemption 1 protects from disclosure information concerning the national defense or foreign policy that is currently and properly classified under Executive Order 13526, Section 1.4.

We determined in consultation with the CIA that these documents must also be withheld under section (b) (3) of the FOIA, 5 U.S.C. 552. Exemption 3 protects from disclosure information that is exempt from release by statute. In this instance, the pertinent statute is 50 U.S.C. 3024(i) (1).

The Department of the Army released one document totaling 40 pages with portions denied undersection (b)(l) of the FOIA, 5 U.S.C. 552. Exemption 1 protects from disclosure information concerning the national defense or foreign policy that is currently and properly classified under Executive Order 13526, Section 1.4.
