Dear Mr. Clarke:

This is in further response to your FOIA request 21-48876 regarding records on Captain David Lewis Hrdlicka of the Air Force. An interim response was provided to you on August 23.

In our previous correspondence, we noted that a series among the Records of the Army Staff (Record Group 319) appeared to include a file on Captain Hrdlicka, but that we were unable at the time to confirm that. It is A1 Entry 1844, 902nd Military Intelligence Group; Vietnam Conflict Prisoners of War (POW), Missing In Action (MIA), and Detainee Intelligence Files, 1944-1986. We have been able to confirm that a file on Captain Hrdlicka is in the series, but that it needs to be reviewed by our Special Access and FOIA Staff (RF).

This completes this office's processing of your request. However, since the records responsive to your request need to be reviewed for categories of information exempted from disclosure under the Freedom of Information Act (FOIA), we are transferring your request to the Special Access and FOIA staff for further action. The Special Access and FOIA staff will be in contact about the status of your request.

Dear Mr. Clarke:

This email is in reply to your Freedom of Information Act request of May 21, 2021, for records related to the whereabouts of James Kelly Patterson of the Navy and Captain David Lewis Hrdlicka of the Air Force. Your request was received in this office on August 5. It has the tracking number 21-48876.

Based on an available folder list, one series among the Records of the Army Staff (Record Group 319) does appear to include a file on Captain Hrdlicka. It is A1 Entry 1844, 902nd Military Intelligence Group; Vietnam Conflict Prisoners of War (POW), Missing In Action (MIA), and Detainee Intelligence Files, 1944-1986. We were unable to locate records specifically on Mr. Patterson. Having information on their respective units at the time may be useful, although unit records may not have been transferred to our custody yet.

Due to the COVID-19 pandemic and pursuant to guidance received from the Office of Management and Budget (OMB), the National Archives and Records Administration (NARA) has adjusted its normal operations to balance the need of completing its mission-critical work while also adhering to the recommended social distancing for the safety of our staff. As a result of this re-prioritization of activities, we are not able to provide thorough responses to requests which require us to consult or provide undigitized materials from the archives at this time.
