This is in further response to your Freedom of Information Act (FOIA) request for access to records in the custody of the National Archives and Records Administration (NARA). Our office received your request for various records relating to possible Prisoners of War on June 26, 2020.

We assigned your request the case number listed above. Please use this number when communicating with us regarding your case so we can easily identify it.

Your request is seeking access to 21 documents as described in the withdrawal sheets included in your request. Five of the documents you requested, totaling 322 pages, have previously been declassified by various agencies and released. Ten of the documents you requested, totaling 107 pages, were declassified in part, with the remaining portions denied on 49 of those pages under section (b)(l) of the FOIA, 5 U.S.C. 552. Please note that several of these documents have been released previously to Messrs. Sauter and Zimmerlee as reflected on the attached disposition list.

NARA has limited authority to release national security information and other sensitive information. Under 5 U.S.C. 552(a)(6)(B)(iii)(III), copies of the remaining 6 documents totaling 73 pages which you requested were sent to the appropriate agencies for further review. In addition the 10 documents previously released in redacted form are also being reconsulted with the appropriate agencies. We will notify you as soon as we process the agency determinations on the documents you requested.

Did you understand our response to your inquiry? If not, please tell us why so we can improve our responses.

Please refer to the attached chart for details regarding the records that are open and available for research as well as those records that were previously provided to either Messrs. Sauter and Zimmerlee.

Under normal circumstances, you or your representative may view the open material in the research room at the National Archives at College Park. However, due to the COVID -19 public health emergency. NARA research rooms are currently closed to the public. You should monitor the NARA website at www.archives.gov for information on the reopening of the research rooms.

NARA is not currently accepting or fulfilling reproduction requests.
