Scope & Content: This series consists of electrostatic copies of documentation from mainly Soviet sources relating to the status and fate of American military personnel during the World War II, Korean War, Vietnamese War, and Cold War eras. The documentation consists of diplomatic exchanges, Soviet internal documentation, and published articles concerning aircraft incidents and ground situations in which American personnel were involved. The majority of the documentation is in the Russian language with a small percentage in English.
